Family and business have always been the core of Walker Meats, which was started by brothers Bobby and Donald Walker more than 30 years ago, and their family's values are reflected in the company's priorities.

"We value people and relationships," said Bill Walker. "Our family believes in helping others in need and doing what we can to make life better for people."

Special 'Thank You' to Pat Robertson



In 1994, when Pat Robertson was told that the local hospice service was looking for volunteers, she knew this was the opportunity for her. What she didn't know was that Tanner Hospice Care would be part of her life for more than 18 years.

"It's a privilege and a calling, it's not just a job," Robertson said of her service. She began as a volunteer in January 1994 and was hired as a counselor just a few months later, putting her education to excellent use. Robertson earned her bachelor's in psychology and public social services at Kennesaw State University, and her master's and specialist's degrees from the University of West Georgia.

In 1997, Robertson became the executive director of the hospice agency and oversaw its merger with Tanner Health System. Following the merger, she took on her role as counselor and was instrumental in launching some of Tanner Hospice Care's signature programs, including the Grief Support Group.

"The Grief Support Group was always my favorite, because I got to spend


weeks with the members of the group and I got to see them get better," said Robertson. The "spinoff" program, Healing Hearts, is another favorite. The group meets each month to share a meal and a social activity, such as playing games or making crafts. "It's very important for people who are in the grief process to reconnect socially, and one of the hardest things is to get back to a social life."

"I can't even begin to put into words how much I have learned from

Pat," said Neda McDonald, M.Ed, bereavement coordinator for Tanner Hospice Care. "She has such a wealth of knowledge, both from her educational accomplishments and from the wisdom she has garnered through her life experiences. I have been so blessed to work with her at Tanner Hospice Care. She will be greatly missed."

Kathy Booth, administrative assistant for Tanner Hospice Care, agrees. "More than anything else, I've learned from Pat to ask myself 'Is it right?'" said Booth, who has worked alongside Robertson for her entire career at Tanner. "When I'm trying to make a decision, the last and most important question I ask myself is whether, in my heart, it is the right thing to do. I learned this from Pat, because she puts her heart into everything she does."

Robertson's retirement plans include spending quality time with her husband and "puttering" in her English garden, which boasts roses, zinnia, Gerbera daisies, marigolds and all colors of lilies.

Tanner Hospice Care extends deepest gratitude to Robertson for her many years of service and volunteerism that has touched countless lives in our community.
